1. INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO) is a National Facility of the National Research Foundation (NRF) that houses and operates South Africa’s national radio telescope shared facilities, including the MeerKAT, KAT-7, and the Hartbeesthoek Radio Astronomy Observatory (HartRAO).

The SARAO project office has offices based in Johannesburg and Cape Town, as well as the radio protected, SKA host site in the Karoo, 90km from Carnarvon in the Northern Cape. The Karoo site shall host the Square Kilometre Array mid-frequency telescopes, and already hosts the MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope.

The Johannesburg office currently based in Rosebank has to relocate to the NRF owned premises located in Observatory, Johannesburg (18a Gill Street, SAASTA Building). Before the relocation process can commence, SARAO requires a thorough Safety, Health and Environmental (SHE) inspection of the building and site, including particularly the assessment and recommendation for the treatment of any asbestos, or other hazardous materials, that may be present at the building/site. This consist of a comprehensive SHE Legal inspection/ Walk-about to identify potential SHE hazards including Asbestos.

2. REQUIRED GOODS AND SPECIFICATION

2.1 Deliverables/ Requirements

The scope of work for this category may include, but is not necessarily limited to, the following components as listed below:

- On-site walk-about inspection, evaluation, sample collection and quantification to identify potential SHE hazards including Asbestos Containing Material (ACM).
- SHE inspection report indicating compliance measures to be taken.
- Guidance report for a cost effective Implication Programme to ensure that all identified hazards are evaluated and controlled or removed.
- Perform and comply with all proper Occupational Health and Safety Act: Asbestos Regulation, GNR No. R155 of 10 February 2002.
