1. INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO, formerly in part SKA SA) is the business unit of the National Research Foundation (NRF) that houses and operates South Africa's national radio telescope shared facilities, including the MeerKAT, KAT-7, and Hartbeeshoek 26-m radio telescopes.

The SARAO project office has offices based in Johannesburg and Cape Town, as well as the radio-quiet SKA host site in the Karoo, 90km from Carnarvon in the Northern Cape, which hosts the Square Kilometre Array Mid-frequency telescopes, MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope.

SARAO acquired an existing Construction Camp which is currently located at Meys Dam farm. After the completion of the MeerKAT project, the camp will no longer be used. The intention now is for the camp to be relocated to Klerefontein and provide additional accommodation for staff/ project teams. The proposed location for the camp has been identified and the necessary Civil Engineering design work services i.e. Site Preparation, Water and Sewer Reticulation, Septic Tanks and Perimeter Fencing, will be required including on site verification and approval of the works.

2. REQUIRED GOODS AND SPECIFICATION

Quotations are invited for the services of an experienced Civil Engineer to provide the necessary Civil Engineering design work services. These services will include the initial Site Inspection to the existing Meysdam temporary accommodation camp [GPS Coordinates 30°43'37.3"S 21°27'25.1"E] and the proposed Klerefontein Staff Accommodation [GPS Coordinates 30°58'09.8"S 21°58'55.1"E]; to provide an optimised design, Site Surveys including setting out, Construction ready designs for the required works including the necessary details and specifications (Site Preparation, Water and Sewer Reticulation, Septic Tanks and Perimeter Fencing, as seen in figure 1 below), on

Civil Engineering Design Work Services to provide construction ready designs including necessary details/ specifications documentation required for the scope of work listed below:

- Site inspection of existing Meysdam Temporary Accommodation Camp & proposed Klerefontein Staff Accommodation, to provide an optimised design
- Site Surveys including setting out survey of final design
- Site preparation
- Water Reticulation
- Waste Water Reticulation (Sewage System)
- Septic Tank design
- Perimeter Fencing

All final designs will be reviewed and approved by SARAO before final acceptance. All drawings will be signed off by the registered Resident Engineer/ Design Engineer. Final accepted drawings must be provided in both soft and hard copy. One (1) hard copy size A0 and soft copy in Pdf, dwg, dxf, Visio, etc. format on a USB flash drive must be submitted SARAO appointed Project Manager.

On site verification and final approval of the executed works by the SARAO appointed contractor, will be required on an Ad Hoc basis. The exact dates for the required visits will be agreed upon during the design phase.

The Civil Engineer Consultant shall have and provide the following:

- Minimum 10 Years' experience in designing bulk civil infrastructure of a similar nature include roads, etc.

- Certified copy of Professional Registration
- Certified copy of Insurance Cover (Professional Indemnity)
- A detailed Curriculum Vitae including projects of a similar nature

2.3 Timelines

The commence dates for the first contact session/ kick-off meeting will be confirmed, following contract award of the successful bidder.

The final designs shall be provided five (5) weeks after the first session/ kick-off meeting.

2.4 Delivery format

The final accepted drawings must be provided to the SARAO appointed Project Manager in both soft and hard copy. One (1) hard copy size A0 and soft copy in electronic format (Pdf, dwg, dxf, Visio, MS Word, Excel, etc.) format on a USB flash drive.

2.5 Contract Terms

SARAO reserves the right to terminate the contract and use another service provider at any time if required services are not achieved.
