## 1. INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO, formerly in part SKA SA) is the business unit of the National Research Foundation (NRF) that houses and operates South Africa’s national radio telescope shared facilities, including the MeerKAT, KAT-7, and Hartbeeshoek 26-m radio telescopes.

As a member of the international effort to build the Square Kilometre Array (SKA), which will be the world’s largest radio telescope, South Africa (through the NRF’s business units) is responsible for the construction and operation of the MeerKAT precursor telescope, for hosting the SKA Mid Frequency telescope, and for implementation of the African VLBI Network.

The SARAO project office has offices based in Johannesburg and Cape Town, as well as the radio-quiet SKA host site in the Karoo, 90km from Carnarvon in the Northern Cape, which hosts the Square Kilometre Array mid-frequency telescopes, MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope.

### **3. PURPOSE:**

SARAO invites the submission of quotations for the appointment of an external recruitment service provider to assist with the hard-to-fill positions on an Adhoc basis for the upcoming organizational vacancies.

### **4: BACKGROUND:**

SARAO is a Project of the National Research Foundation [NRF] and the Department of Science and Technology [DST] currently constructing the MeerKAT telescope which will be the world's leading telescope in its class. Due to the nature of the project, our organisation requires highly skilled staff trained in the Information Technology and Engineering disciplines as required by the project.

For these highly skilled incumbents, SARAO holds a responsibility to ensure the successfully appointed applicants hold the necessary qualifications, skills and experience. A 360- degree external recruitments service is required to assist with the hard-t fill vacancies on an Adhoc basis.

The external recruitment agency will assist in finding suitable candidates including application from previously disadvantaged backgrounds in line with our Employee Equity targets. The agency will be responsible for the; Head-hunting, conducting two [2] professional references for selected applicants as well as background screening and verification which includes, criminal and credit checks [as required], qualification verification checks and identification verification checks.

### **5. PROCUMENT PROCESS:**

The external recruitment service providers will be provided with the job specification for current vacant positions within SARAO and given the mandate to find suitable qualified applicants who meet the minimum criteria of the job specification.
