1. INTRODUCTION TO SARAO

The South African Radio Astronomy Observatory (SARAO, formerly in part SKA SA) is the business unit of the National Research Foundation (NRF) that houses and operates South Africa's national radio telescope shared facilities, including the MeerKAT, KAT-7, and Hartebeesthoek 26-m radio telescopes.

As a member of the international effort to build the Square Kilometre Array (SKA), which will be the world's largest radio telescope, South Africa (through the NRF's business units) is responsible for the construction and operation of the MeerKAT precursor telescope, for hosting the SKA Mid Frequency telescope, and for implementation of the African VLBI Network.

The SARAO project office has offices based in Johannesburg and Cape Town, as well as the radio-quiet SKA host site in the Karoo, 90km from Carnarvon in the Northern Cape, which hosts the Square Kilometre Array mid-frequency telescopes, MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope.

The Johannesburg office currently based in Rosebank has to relocate to the NRF owned building located in Observatory Johannesburg (18a Gill Street, SAASTA Building). Before the relocation process can commence, SARAO requires a Conservation Architect to assess the heritage structures on site. This assessment must confirm the listed grading of the buildings, provide historical context of the structures and provide a heritage Conservation Management Plan if required.

2. BACKGROUND

The main objective of the Safety, Health, Environment and Quality (SHEQ) unit at SARAO is to emphasise the importance of protection of SARAO staff, employees, stakeholders, visitors, contractors, environment, SARAO assets, the community at large and SARAO company property which is of paramount significance to the success of all SARAO projects. SHEQ is committed to implementing the principles, disciplines and control functions of integrated SHEQ processes into all spheres of SARAO activities. Its function serves as a baseline management tool and guidelines for SHEQ within SARAO. This applies to all permanent, temporary and casual employees as well as contractors, visitors and stakeholders on any SARAO premises. The main objective of SHEQ is to achieve and establish a "zero harm culture" and to emphasize that management and each employee of SARAO is responsible for occupational health, safety and the natural environment.

4. SUPPLY SPECIFICATIONS

SARAO invites proposals from service providers that can render occupational medical services to SARAO, specifically, for staff who work on site in the Northern Cape. These services are required for a period of three years, as and when required.

There are approximately 150 employees working at the SARAO site

Deliverables/ Requirements

The scope of work for this category may include the following as listed below:

- (a) Management of Occupational and Primary Health Services, Injuries and Disease management;
- (b) Providing and Monitoring quality patient care and issuing of medical screening certificate of fitness for pre-employment. Initials, periodicals, exits and transfers;
- (c) Assist and responsible for health risks assessments and workplace inspections;
- (d) Organizing preventative medical programmes, promoting health education, and referrals. Submitting of monthly reports and stats;
- (e) Combat absenteeism, incapacity and case management
